Additionally, information may be required to be disseminated to law enforcement and/or, government bodies such as the Chief Firearms Officer in the event of an audit, investigation, or other lawful act in which disclosure of membership information is required.

By providing your name and email address, unless expressly indicated on the from page of the form under **Declaration**, you agree to the use of this information in the distribution of regular electronic messaging in the form of newsletters, event information, and other communications from the executive to the membership whole. You have the right to opt-out of these communications at any time, and if available, you may also tailor the communications you wish to receive to reduce the amount of electronic communication we send to you. You cannot opt-out of important communications which expressly provide information to the operation of the club, directives, adjustments to rules and regulations or notifications of important events such as membership renewal reminders.

Steps to complete the Membership process requirements for the Elmira & District Rod and Gun Club

- 1) Submit this completed application form with your sponsor at a member's meeting. The non-refundable application fee is due at this time.
 - 2) Volunteer at 2 events at the club (tracked on Activity Record).
 - 3) Complete 2 competency assessment shoots supervised by an executive of the club (tracked on Activity Record).
 - 4) Provide a police background check to the executive of the club (must be dated within 6 months of consideration for membership - step 5).
 - 5) After completion and verification of all steps above you must attend a second member's meeting for consideration of your membership by the club members. If successful, membership fees are due at this time.
 - 6) Completion of a Club orientation.
- * Steps 2 - 5 must be completed within 12 months from the date your application is accepted or you will lose your position and must re-apply.
